D. Rest Periods

Two ten minute rest periods are allowed to employees daily, one in the middle of the first four hour block of the work day and the second in the second four hour block, the last half of the work day. The ten minute rest periods are optional and generally, must be approved by the supervisor. No unused ten minute, rest period may be used to shorten the work day.




Ingredients:
